

Steps taken up by the authority:

- 3 Sept 1939 - 3 May 1945 - End the II World War
- 24 October 1945 - Established the UNO
- 30 October 1945 - India become UNO Member, Charter signed by Sir Ramasawmi Mudaliar is an Indian

- 23 March 1946 - Cabinet Mission team arrived in India

- 12 May - Cabinet Mission Memorandum

- 16 May - Cabinet Mission Plan

- 12 August - Election in British India

- 2 September - Interim Government formed Jawaharlal Nehru as Prime Minister (It is the Successor Government of the Government of India)

- 27 December - Manipur State declared as **Excluded Area** by Order in Council
Manipur excluded from India [Empire of India]
Suzerainty laps over the State of Manipur

- 1 January 1947 - *Manipur State Constitution Act 1947* enacted by His Highness the Maharaja as sovereign authority and enforced on 2 January 1947.

- 24 March - Mountbatten became the Governor General of India

- 3 June - Mountbatten Plan (Partition of British India)
 - Dominion of India
 - Dominion of Pakistan

- 1 July - Introduced the *Manipur State Administration Rules 1947* as promulgated by His Highness as sovereign authority.

- 1 July - Bilateral agreement reached between the Government of India And Government of Manipur as well as Political Department.

- 2 July - Agreement made between the His Majesty and His Highness.

- 5 July - Set up States' Department

- 15 July - Formed *Interim Council* F.F.Pearson as Chief Minister of Manipur

- 14 August - Constitutes the State Council M.K.Priyobatra as Chief Minister of Manipur. F.F.Pearson hands over the power to M.K.Priyobatra. **Independence Day and transfer Crown Paramountcy. [Government of India by the Crown] Manipur independence got from British.**

- 15 August mid night - Hand over the British Reserve Area to His Highness
- 15 August - Lapses paramountcy over the State
- Restoration of Sovereignty of the State of Manipur
- 15 August 1947 - India [Dominion of India] got independence from British.
Formed an **Indian Government** headed by J. Nehru as Prime Minister
- 11 June 1948** - Election in Manipur under the State Constitution Act 1947
- 18 October - First Assembly Address by His Highness the Maharaja
- 27 November - Constitutional Government formed in Manipur
Political and constitutional arrangement made by the British completed on 21 June 1948.

Political arrangement did not make by Indian. It is interfered in the internal matter of a sovereign State. Indian Government and Indian Governor General of the Dominion has done considerable illegal acts against law:

- 15 October 1949** - Manipur (Administration) Order 1949 passed by GOI
- Overthrown constitutional Government by Indian Government
- Prevent the spirit of Manipur State Constitution Act 1947.
- 22 January 1950 - States' Merger (Chief Commissioners' Provinces) Order 22 January 1950 passed by Indian Governor General of the Dominion.
- Manipur illegally annexed to India by the Indian Government and Manipur occupied by Indian.
- Since 1951-1952 - Republic Constitution of India operates in the Monarchic State of Manipur. Election of India illegally conducted in Manipur. Manipur occupied by Indian more than 68 years.
